- A 50% deposit on the total quotation is required to confirm and guarantee the wedding date and venue.
- Upon confirmation and payment of the deposit, Terms & Conditions must be signed by both parties and returned within two weeks of the confirmation date.
- The remaining balance must be settled 21 days prior to your wedding date.
- Cancellation policy: should the wedding be cancelled 3 month prior to the wedding date, the deposit will be refunded, less an administration fee of R 2000.00. The following cancellation fees apply thereafter:
  - 90 to 60 days prior arrival 50% of the total quotation
  - 59 to 0 days prior arrival 100% of the total quotation
- The client shall be responsible for any damages caused to the allocated rooms, furnishings, utensils and equipment therein, by any act or omission of the client or guests/employees of the client.
- The client will be responsible for the safe keeping of, or any damage caused to equipment hired on their behalf.
- If dancing is required, a 6x4m dance floor will be ordered in for the client's account at R 5500.00 incl. VAT.
- Service providers (florists, photographers, DJs etc.) must be approved by the Lodge.
- The total bar costs must be settled in full on departure. A gratuity of 10% will be added to the final bar account.
